SEASONS: IN MARCH 2020, THE UNITED STATES OF AMERICA DECLARED THE GLOBAL PANDEMIC NOVEL CORONAVIRUS COVID-19 OUTBREAK A NATIONAL EMERGENCY. THE FOUNDATION CANCELED ITS TOURS ORIGINALLY SCHEDULED FOR MARCH AND APRIL 2020, IN ADDITION TO THE SPRING AND FALL SEASONS AT THE METROPOLITAN OPERA HOUSE AND DAVID H. KOCH THEATER, RESPECTIVELY. MANAGEMENT IMMEDIATELY BEGAN TO ASSESS THE POTENTIAL IMPACT OF THE LOSS OF EARNED INCOME SOURCES AND TOOK INITIAL ACTION TO EXAMINE OPPORTUNITIES TO MANAGE COSTS, MAKING REDUCTIONS WHERE FEASIBLE. TO HELP OFFSET LOST REVENUE OPPORTUNITIES, APPEALS WERE MADE TO MAJOR DONORS TO REQUEST ACCELERATION OF THEIR ANNUAL CONTRIBUTIONS, AND TO REQUEST THAT GRANTS BE ALLOCATED TO GENERAL OPERATING EXPENSES RATHER THAN DONOR RESTRICTED

EDUCATIONAL TRAINING AND OUTREACH: IN 2020, AMERICAN BALLET THEATRE'S DEPARTMENT OF EDUCATION AND TRAINING REACHED OVER 240,000 INDIVIDUALS THROUGH SYNCHRONOUS AND ASYNCHRONOUS PROGRAMS. ABT'S PRIMARY OUTREACH PROGRAM IS ABT AT SCHOOL: SERVING 10 NYC SCHOOLS ENGAGING OVER 1,400 STUDENTS. ABT'S STUDENT TRAINING PROGRAMS INCLUDE THE JACQUELINE KENNEDY ONASSIS SCHOOL (360 STUDENTS); SUMMER INTENSIVES HELD VIRTUALLY (1,450 STUDENTS) AND ABT STUDIO COMPANY (15 STUDENTS), A PRE-PROFESSIONAL PROGRAM. KENNEDY CENTER FOR THE PERFORMING ARTS IN WASHINGTON, DC AND THE SEGERSTROM CENTER FOR THE ARTS IN COSTA MESA. ALL REMAINING TOURING FOR 2020 WAS CANCELED DUE TO THE COVID-19 OUTBREAK.
